

Hero of the Month – Terms and Conditions

1. By accepting the reward prize, Studentbox members agree to abide by these Terms and Conditions. Acceptance of the award signifies acceptance of all conditions.
2. This reward program is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 (“Curtin”).
3. The Hero of the Month reward program begins in January 2018 and runs for 12 months until December 2018, (December Hero of the Month decided mid-January 2019)
4. The Hero of the Month will be decided in the first week of the following month.
5. Entry in the reward program is automatic when students become members of Studentbox: Studentbox.com.au
6. To enter the reward program, the entrant must:
 - (a) Be a current high school student in year 10, 11 or 12 and must not be a Curtin staff member or a family member of a Curtin staff member; and
 - (b) Be a registered member of Studentbox.
 - (c) Be helpful and active in the Studentbox community, by commenting and posting on discussions
7. Entry to the reward program is free. Entrants will be responsible for all costs associated with the reward program, which may include costs associated with accessing the internet.
8. Entrants may win Hero of the Month **more than once** in the calendar year.
9. Staff employed by Curtin and their immediate family members are not eligible to be part of the reward program.
10. There will be twelve (12) reward prizes. This reward prize will be a \$25 JB Hi-Fi voucher. This is not redeemable for cash, and must be used by the expiry date displayed on the voucher. Vouchers are electronic vouchers and will be sent to the winner of the Hero of the Month reward via the email address the winner has registered with Studentbox.
11. The Hero of the Month will be decided by a panel of Studentbox administrators and will be based on activity within the Studentbox community (actively posting and commenting), and how helpful that activity is.
12. The Studentbox administrators will select one (1) ‘Hero’ each month. The Hero of the Month, for any given month, will be chosen and rewarded during the first week of the following month. The decision will be made by the Studentbox administrators and is final.
13. The winner of the award will be contacted within seven (7) days of the decision and sent their reward.
14. If the winner of the award does not respond to acknowledge the award prize within seven (7) days of the draw, a new Hero of the Month will be rewarded within fourteen (14) days of the original draw date.
15. The award will be emailed, as a digital gift voucher, to the email address the member has registered with Studentbox.
16. The prize winner, or if under the age of 18 years their parent or legal guardian, may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving the prize.
17. The award winner will be responsible for all costs associated with collecting and using the voucher.
18. The award is not redeemable for cash or an alternative prize.
19. The award is not transferrable.
20. The award winner’s name or username may be published on the Studentbox website.
21. The award winner will receive a ‘Hero of the Month’ reward badge which will be displayed next to their member name.

Curtin accepts no responsibility and shall not be held legally liable or responsible for any accident, loss, injury or damage to any individual or property whether direct or indirect, whether in contract, tort, negligence or otherwise arising out of or in connection with the reward program or the award prize, either during or after the award program duration.
